

NOTICE OF INTENT TO ISSUE PAYROLL DEDUCTION SLOT
FOR VOLUNTARY SUPPLEMENTAL BENEFITS
REQUEST FOR INFORMATION

In accordance with Section 3-123g of the Connecticut General Statutes, the State Comptroller's Vendor Advisory Committee (VAC) is soliciting information from vendors interested in providing products and services to State employees and retirees under the Supplemental Benefits Program (Program). The State of Connecticut currently employs approximately 78,000 State employees of which approximately 55,000 would be eligible for the Program. The entire cost of selected services is borne by employees and will be remitted to selected vendors through voluntary payroll deductions. A subsequent Request for Proposal (RFP) will be issued to companies that responded to this Request for Information (RFI) for products and services that the VAC wishes to authorize. Based upon the VAC's recommendations, the Comptroller intends to authorize selected applicants to market approved products and services to State employees and retirees for a two-year period, commencing January 1, 2021, with up to three optional one-year extensions.

The current Program offers six supplemental benefits: (1) short term disability insurance; (2) long term disability insurance; (3) auto and homeowners insurance; (4) universal life insurance; (5) term life insurance; and (6) long term care insurance.

Information relating to product and service offerings should be as specific as possible and include at least the following information: (1) the name and mailing address of the applicant; (2) a detailed description of the proposed product or service; (3) the name, address and telephone number of any agent of the applicant from whom additional copies of the application can be obtained; (4) detailed information on the financial ability of the applicant; (5) detailed information on past performance; (6) the applicant's business history and experience; (7) proposed pricing for the product or service; (8) the value to be derived by employees and retirees electing to purchase the proposed product or service, taking into consideration the full range of benefits currently offered by the State; and (9) at least three references.

The VAC will only consider one response per company per product. To be considered, RFI responses (one original copy) must be received no later than 2:00 p.m. on Friday, July 24, 2020 at the below address. Each vendor must also submit one electronic copy of its complete response in CD/DVD format or on a thumb drive.

With respect to insurance products it is the State Comptroller's policy to contract only with carriers selected to underwrite the coverage. Accordingly, proposals to provide insurance products must contain the signature of an official authorized to contractually bind the insurer.

By submitting applications in response to this public notice, applicants agree to accept the Committee's recommendations and the Comptroller's determinations as final.
