CHAIRPERSON LIEDERS: Meeting come to order, please.

November 1, 2024, meeting of the Medical Examining Board is now in session. My name is Nikolai Lieders. The other doctors are Dr.

Michael Gerstenfeld, and Dr. Poleak So. Present from the Office of the State Comptroller, Retirement Services Division are staff members from the Retirement Services Division, Mr. Robert Helfand, Helena Bartolomeo and Nabil Waheed. Also general counsel for the Retirement Commission and the Medical Examining Board, Cindy Cieslak.

Well, we have no change in the agenda, so I'm going to make a motion for us to go into executive session. While we are in executive session the public will not participate in the -- during the executive session. After we finish the executive session, they will come back for direction.

So I make a motion for us to enter into executive session, and I'm going to ask for the members of the Retirement Services

Division as well as general counsel to stay for the executive meeting.

Any seconds?

DR. SO: Second.

CHAIRPERSON LIEDERS: Okay. Is there any discussion? All in favor, say aye.

DR. SO: Aye.

DR. GERSTENFELD: Aye.

CHAIRPERSON LIEDERS: All opposed, say may. Motion passes. We are an executive -- going into executive session.

MS. CIESLAK: This is Cindy Cieslak. What that means for all of the members of the public and the applicants here, I'm going to place you back in the waiting room. The doctors are going to review your medical information in executive session so that that's not part of the public record. And then those who are on reconsideration will be invited in to make their statement. And then after the doctors have reviewed everyone, we will reenter public session, at which time you'll be able to hear the doctors make a decision on your application.

(The board was in executive session from 9:07 a.m. until **)

CHAIRPERSON LEIDERS: All right. So let me just tell you that the board will be making determinations and voting on those determinations. But I would like to remind members that only the final vote will be given today and not the reasons for the vote. In some cases there may not have been enough medical information to make a determination, or perhaps a non-service connected disability is more likely than a service connected disability. You may seek reconsideration of an initial denial. You will also receive the board's written determination within 2 to 4 weeks, which will provide you with that additional information. So proceeding to vote, I make a motion to deny Terrance Anderson's application for service

connected disability retirement.

MS. KALLOR: Is there a second?

DR. SO: So, second.

MS. KALLOR: All in -- any discussion? All in favor?

CHAIRPERSON LEIDERS: Leiders, aye.

DR. SO: So, aye.

DR. GERSTENFELD: Gerstenfeld, aye.

CHAIRPERSON LEIDERS: I'm sorry?

CHAIRPERSON LEIDERS: Yeah. I'll make a motion to table Daniel Currin's application for non-service connected disability retirement.

CHAIRPERSON LEIDERS: Well? Yeah. I guess we complete this. So, I make a motion to adjourn today's meeting.

DR. SO: So, second.

MS. KALLOR: Any discussion? All in favor.

CHAIRPERSON LEIDERS: Leiders, aye.

DR. SO: So, aye.

DR. GERSTENFELD: Gerstenfeld aye.

MS. KALLOR: Meeting is adjourned.

CHAIRPERSON LEIDERS: Meeting is adjourned.

MR. ZIMBERLIN: Can I ask one question? Barbara Fritz opted into the non-service connected, so I was wondering if that could be approved today as opposed to looked favorably upon just so she doesn't have to come back here next month.

CHAIRPERSON LEIDERS: I don't think she needs to come back. We'll just -- she'll just make a formal request to change to non-service.

MR. ZIMBERLIN: She's done -- she's done that. Okay. Well, I'll do that. I'll wait for the decision.

MS. KALLOR: Okay, thank you. Meeting is adjourned CHAIRPERSON LEIDERS: Thank you.
