4 CHAIRMAN ADOMEIT: Are we recording now, Cindy? All 5 right. This is a State Employees Retirement Commission regular 6 monthly meeting, being held using Zoom technology. Do you have 7 the attendance Cindy?

8 MS. CIESLAK: Yes. Present this -- this is Cindy 9 Cieslak. Present this morning we have Chairman Peter Adomeit, 10 Trustee Michael Bailey, Trustee Karen Buffkin, Trustee Michael Carey, Trustee Carl Chisem, Trustee John Disette, Tara Downes, 11 12 Deputy Comptroller and Ex Officio member of their retirement 13 commission. Trustee Brian Hill, Trustee David Krayeski, Trustee Sal Luciano, Trustee Karen Nolan, Trustee Michael 14 15 O'Brien, Actuarial Trustee Claude Poulin, Trustee Angel Quiros, 16 Actuarial Trustee Tim Ryor, Trustee Rebecca Simonsen, and Chief 17 Investment Officer, Office of the Treasurer, Ex Officio member 18 of the Retirement Commission, Ted Wright. From the Retirement 19 Services Division, Division Director John Herrington. 20 Assistant Director Robert Helfand and Ben Sedrowski. From Rose

21 Kallor. General Counsel, Michael Rose and Cindy Cieslak. And 22 if I missed anyone, please just let me know. I know we had a 23 couple different meeting links, so I might have missed getting 24 someone in. Thank you.

25 CHAIRMAN ADOMEIT: Okay. Thank you. I'll refer to

1 John Herrington. John?

2 MR. HERRINGTON: Yes. Good morning everyone. Again, we have a pretty standard month in terms of the director's 3 4 report. We are creeping back up towards historical averages 5 for the numbers of retired. What we continue to focus on as 6 division is working through the automatic enrollment of 7 individuals in the plan. We have a default enrollment over the 8 past couple of years with the launch of the new system and the additional rules with Tier 4 and with the pandemic. 9

10 There have been, you know, some issues that we've 11 dealt with agencies correctly placing individuals and plans 12 initially upon hire. We've come up with a technological 13 solution to that, to default members into the plan based on the 14 contractual defaults that seems to be working rather well on 15 the DC side. With respect to Tier 4 and the alternate 16 retirement plan.

17 We are continuing to consider which aspects of the 18 secure 2.0 we are going to be able to program and we hope to 19 have that project all set by January 1st so that we can 20 implement any changes. That means that there will likely be a need to consider some changes to the plan documents. We should 21 22 have an initial set of proposals within the next couple of 23 weeks. First for legal and personnel, and then for the full commission to consider. 24

25 CHAIRMAN ADOMEIT: Thank you, John. Any questions or

1 comments? Okay. Hearing none, let's go into new matters. 2 MR. BAILEY: Morning everyone. Mr. Chairman, this is Michael Bailey. I move approval of the State Employee's 3 4 Retirement Commission minutes with director's report from 5 August 20,, 2024. 6 MR. LUCIANO: Sal Luciano. Second. 7 CHAIRMAN ADOMEIT: Any discussion? All in favor say, aye or 10 raise your hand. 11 UNIDENTIFIED SPEAKER: Aye. 12 CHAIRMAN ADOMEIT: Opposed, nay and raise your hand. 13 The ayes have it. 14 MR. BAILEY: Mr. Chairman, Michael Bailey, I move 15 approval of the State Employees Retirement Commission 16 Management Trustee, Timothy Ryor's per diem expenses for 17 August, 2024. 18 MR. LUCIANO: Sal Luciano. Second. 19 CHAIRMAN ADOMEIT: Any discussion? 2 CHAIRMAN ADOMEIT: Okay. Go ahead. Thank you. 3 MR. BAILEY: Acceptance of invoices from Robinson Cole for tax matters and services and from invoices from Robert 4 5 -- Rose Kallor for executive session for August, 2024. 6 MR. LUCIANO: Sal Luciano. Second. 7 CHAIRMAN ADOMEIT: Any discussion? Hearing none. 8 All in favor, say, aye or raise your hand. Opposed, nay and 9 raise your hand. The ayes have it unanimous. 10 MR. BAILEY: Mr. Chairman, I move Items 8, 9, 10, and 11 11 on the agenda approval of the Connecticut State employees' 12 retirement systems, service retirements, voluntary pending 13 retirements, disability retirements, and retroactive 14 retirements for August, 2024. MR. LUCIANO: Sal Luciano. Second. 15 16 CHAIRMAN ADOMEIT: Any discussion? Hearing none. All in favor say, aye or raise your hand. 17 18 UNIDENTIFIED SPEAKER: Aye. 19 CHAIRMAN ADOMEIT: Opposed, nay or raise your hand. 20 Unanimous, the ayes have it. 21 MR. BAILEY: Mr. Chairman, Michael Bailey, I move 22 approval of the Connecticut State employees' retirement 23 systems, pre-retirement death benefits for August, 2024. MR. LUCIANO: Sal Luciano. Second. 24 25 CHAIRMAN ADOMEIT: Any discussion? Hearing none.

2 UNIDENTIFIED SPEAKER: Aye.

3 CHAIRMAN ADOMEIT: Opposed, nay or raise your hand.4 It's unanimous, the ayes have it.
