This is the 5 December 13th, 2023 meeting of the Legal & Personnel 6 7 Subcommittee of the Connecticut State Employees 8 Retirement Commission being held remotely. Cindy, do you have the attendance, please? 9 10 MS. CIESLAK: Yes. Good morning. This is 11 Cindy Cieslak. Present today, we have Chairman Peter Adomeit, Trustee Michael Carey, Trustee Brian Hill, 12 Trustee Sal Luciano, Trustee Michael O'Brien. From the 13 Retirement Services Division, Division Director John 14 15 Herrington, Robert Helfand, and Ben Sedrowski. We have Assistant Comptroller and General Counsel Yam Menon. 16 From Robinson & Cole Tax Counsel, we have Bruce Barth 17 and Virginia McGarrity. And from Rose Kallor, General 18 19 Counsel, we have Mike Rose and Cindy Cieslak. 20 CHAIRMAN ADOMEIT: Okay. So we are now operational and recording. Motion to approve the 21 agenda, please? 22 23 MR. LUCIANO: So moved, Sal Luciano. MR. O'BRIEN: Second, Mike O'Brien. 24 25 CHAIRMAN ADOMEIT: All in favor, say aye or

1 raise your hand. 2 MR. LUCIANO: Aye. 3 CHAIRMAN ADOMEIT: Opposed, nay or raise your 4 hand. It's unanimous; the ayes have it. New business, we need a motion to go into 5 executive session, please. 6 7 MR. LUCIANO: So moved, with the usual people invited that contribute to the-8 9 CHAIRMAN ADOMEIT: That name was Sal Luciano. MR. O'BRIEN: Second, Mike O'Brien. 10 11 CHAIRMAN ADOMEIT: Okay. All in favor, say aye or raise your hand. 12 MR. LUCIANO: 13 Aye. CHAIRMAN ADOMEIT: Opposed, nay or raise your 14 15 hand. The ayes have it. 16 Cindy? MS. CIESLAK: This is Cindy Cieslak. 17 Those who were invited into executive session were Yam Menon, 18 19 John Herrington, Ben Sedrowski, Bert Helfand, Cindy 20 Cieslak, Viriginia McGarrity, Bruce Barth, and Michael 21 Rose. (The subcommittee was in executive session 22 23 from 8:38 a.m. until 9:27 a.m.) MR. LUCIANO: This is Sal Luciano and I'd 24 like to make a motion that Chris Darling - that the 25

Chris Darling matter be tabled until next month. 1 MR. O'BRIEN: Second, Mike O'Brien. 2 3 CHAIRMAN ADOMEIT: Any discussion? Hearing none, all in favor, say aye or raise your hand. 4 Opposed, nay or raise your hand. Unanimous; the ayes 5 have it. 6 7 MR. LUCIANO: And I'd like to make a motion 8 regarding the Ahlquist case that we recommend to the full commission that we deny his ability to buy his 9 military time - well, actually, what precluded from 10 allowing him to buy military time, because he already 11 bought it from Hartford Police Department, and we also 12 deny his request to go to the MEB for the third time. 13 MR. O'BRIEN: Second, Mike O'Brien. 14 15 CHAIRMAN ADOMEIT: Is there any discussion? Hearing none, all in favor, say aye or raise your hand. 16 Opposed, nay or raise your hand. Unanimous; the ayes 17 have it. 18 19 Okay. We're down to the last item, adjournment. (Inaudible) old business. 20 MS. CIESLAK: Mr. Chairman? 21 CHAIRMAN ADOMEIT: Yeah, go ahead. 22 23 MS. CIESLAK: Mr. Chairman, this is Cindy Cieslak. I believe there was going to be a motion on 24 Mr. Kelso as well. 25

LUCIANO: Thank you, Cindy. 8 CHAIRMAN ADOMEIT: Yeah. 9 MR. LUCIANO: Yeah, so moved, Sal Luciano. 10 11 CHAIRMAN ADOMEIT: Thank you, Sal. MR. O'BRIEN: Second, Mike O'Brien. 12 CHAIRMAN ADOMEIT: All right. 13 MR. O'BRIEN: I have a guick guestion 14 15 (inaudible). 16 CHAIRMAN ADOMEIT: All in favor, say aye or raise your hand. 17 MR. O'BRIEN: Peter, I have a quick question. 18 19 CHAIRMAN ADOMEIT: Sure. Mike. MR. O'BRIEN: Is that before the full -20 21 hearing before the full commission, or before this subcommittee? 22 23 MS. CIESLAK: This is Cindy Cieslak. 24 Typically, it's before the full commission. CHAIRMAN ADOMEIT: Okay. All set for the 25

1 motion? All in favor, say aye or raise your hand. 2 Opposed, nay or raise your hand. The ayes have it, 3 unanimous. MR. LUCIANO: Because of the timing, this 4 will likely be the January board meeting? 5 CHAIRMAN ADOMEIT: Yes, it would have to be. 6 MR. LUCIANO: Okay. Motion to adjourn, Sal 7 Luciano. 8 MR. O'BRIEN: Second, Mike O'Brien. 9 CHAIRMAN ADOMEIT: All in favor, say aye or 10 11 raise your hand. Opposed, nay or raise your hand. The ayes have it. 12 We'll see you next week. 13 14 MS. CIESLAK: Thank you. MR. O'BRIEN: Thank you, everyone. See you 15 16 next week. UNIDENTIFIED SPEAKER: See you next week. 17 Bye, everyone. 18 19 MR. CAREY: Auf Wiedersehen.
