Hold on one second. 8 Dr. Rudich, you can proceed when you're 9 10 ready. 11 CHAIRPERSON RUDICH: Okay. The January 5th, 2024 meeting of the Medical Examining Board is now in 12 session. I am Dr. Lynn Rudich. We also have Dr. Ralph 13 Rosenberg and Dr. Frank Gerratana. Present from the 14 15 Office of the State Comptroller, Retirement Services Division, are Robert Helfand, William Cassada, and 16 Helena Bartolomeo. General Counsel for the Retirement 17 Commission and Medical Examining Board is also here. 18 19 She is Cindy Cieslak. 20 I make a motion to go into executive session, but I request that members of the Retirement Services 21 Division and counsel be allowed to remain. Is there a 22 23 second? DR. GERRATANA: Gerratana, second. 24 CHAIRPERSON RUDICH: Any discussion? All in 25

1 favor, say aye. Rudich, aye. 2 DR. ROSENBERG: Rosenberg, aye. 3 DR. GERRATANA: Gerratana, aye. 4 CHAIRPERSON RUDICH: Motion passes. We, as the Medical Examining Board-5 MS. CIESLAK: I made that mistake. This is 6 7 Cindy Cieslak. I apologize. Sometimes when I go to 8 unmute myself, I stop the recording. I apologize. So we're going to go into executive session. 9 This means that the members of the public and the 10 11 applicants who are here, I am going to place you back in the waiting room. The doctors discuss your medical 12 information in executive session, which is private so 13 14 that your medical information is not shared with the 15 public. Stay in the waiting room, and then those who are on reconsideration will be invited in to make their 16 statement. And then after they've reviewed all of the 17 matters, we will enter public session and the doctors 18 19 will vote on the matters. 20 You know, sometimes this meeting can run a couple of hours, so you might be in the waiting room 21 for a little bit. So I just wanted to give you the 22 23 heads up. So I'm going to place everyone in the waiting room, and we'll be back in touch. 24 (The board was in executive session from 9:06 25

a.m. until 11:40 a.m.) 1 2 MS. CIESLAK: Dr. Rudich, you can proceed 3 when you're ready. CHAIRPERSON RUDICH: The board will be making 4 determinations and voting on the determinations, but 5 would like to remind the members that only a final vote 6 7 will be given today and not the reasons for the vote. 8 In some instances, there may not have been enough medical information to make a determination, or perhaps 9 a non-service-connected disability is more likely a 10 11 service-connected disability. You may seek reconsideration of an initial 12 denial. You will receive the board's written 13 determination within two to four weeks, which will 14 15 provide additional information. I make a motion to approve the service-16 connected disability retirement of Jennifer Busse. 17 Ιs there a second? 18 19 DR. GERRATANA: Gerratana, second. 20 CHAIRPERSON RUDICH: Any discussion? 12	favor, say aye. Rudich, aye.

14	DR. ROSENBERG: Rosenberg, aye.
15	CHAIRPERSON RUDICH: Motion passes.

18	continuation.

ROSENBERG: Rosenberg, aye. 7 CHAIRPERSON RUDICH: Motion passes. 8 I make a motion to deny the service-connected 9 10 disability retirement of Rosalind Payne, but approve 11 non-service-connected disability retirement. DR. GERRATANA: Gerratana, second. 12 CHAIRPERSON RUDICH: Any discussion? 13 All in 14 favor, say aye. Dr. Rudich, aye. 15 DR. GERRATANA: Gerratana, aye. DR. ROSENBERG: Rosenberg, aye. 16 CHAIRPERSON RUDICH: Motion passes. 17 18 I make a motion to deny the service-connected 19 disability retirement of Wilfredo Rivera, but approve non-service-connected disability retirement for him. 20 21 DR. GERRATANA: Gerratana, second. CHAIRPERSON RUDICH: Any discussion? All in 22 23 favor, say aye. Rudich, aye. DR. GERRATANA: Gerratana, aye. 24 DR. ROSENBERG: Rosenberg, aye. 25

1 CHAIRPERSON RUDICH: Motion passes. 2 I make a motion to deny the service-connected 3 disability retirement of Marcy Tremaglio, but approve 4 non-service-connected disability retirement. DR. GERRATANA: Gerratana, second. 5 CHAIRPERSON RUDICH: Any discussion? All in 6 7 favor, say aye. Rudich, aye. DR. GERRATANA: Gerratana, aye. 8 DR. ROSENBERG: Rosenberg, ave. 9 10 CHAIRPERSON RUDICH: The motion passes. The board session is now concluded. 11 MS. CIESLAK: This is Cindy Cieslak. There's 12 no further business, so if one of doctors wants to make 13 a motion to adjourn. 14 15 CHAIRPERSON RUDICH: I make a motion to adjourn the meeting. 16 DR. GERRATANA: Gerratana, second. 17 CHAIRPERSON RUDICH: Any discussion? All in 18 19 favor, say aye. Rudich, aye. 20 DR. GERRATANA: Gerratana, aye. 21 DR.
