7 CHAIRPERSON RUDICH: Okay. April 19th, 2024 8 meeting of the Medical Examining Board is now in session. We have Dr. Frank Gerratana, Dr. Manny 9 Katsetos, and myself, Dr. Lynn Rudich. Present from 10 11 the Office of State Comptroller, Retirement Services Division, are staff members Robert Helfand, William 12 Cassada, Helena Bartolomeo, and Nabil Waheed. We also 13 have the General Counsel to the Retirement Commission 14 15 and Medical Examining Board, Cindy Cieslak.
