2 CHAIRPERSON GERRATANA: Thank you Dr.

Rosenberg. Apologize for rushing.

DR. ROSENBERG: Not a problem.

MS. CIESLAK: All right. Everyone, this is Cindy Cieslak, I'm going to place everyone back in the waiting room. The doctors discuss all of your medical information in executive session, which means it's private, not open to the public. Those individuals who are on reconsideration will be invited in to make a statement when the doctors are ready to hear from you, and then at the end, we will reenter public session and everyone will be invited back in so that you can hear the decisions today. This sometimes can be a long process. It can be a couple of hours. So if it seems like you're in the waiting room for a long time, that's how it normally goes, so be patient with us, and then when we reenter public session, we'll let you all back in. Thank you.

MS. CIESLAK: Dr. Gerratana, you can proceed when you're ready.

CHAIRPERSON GERRATANA: The board has just come out of executive session. The board now will be

1 making determinations and voting on those 2 determinations, but would like to remind members that 3 only the final vote will be given today and not the reasons for the vote. In some instances there may not 5 have been enough medical information to make a 6 determination, or perhaps a service connected disability 7 is more likely a non service connected disability. You 8 may seek reconsideration of an initial denial. You will 9 receive the board's written determination within 2 to 4 10 weeks, which will provide you with additional 11 information. The board will now vote the application 12 requests. Concerning Angel Aviles, I move that the 13 request for a service connected disability retirement be 14 denied. Is there a second? 15 DR.
