1 (Proceedings began at 9:01 a.m.) CHAIRMAN GERRATANA: So good morning, everyone. 2 The 3 April 16, 2025 meeting of the Medical Examining Board is now in 4 session. I'm Dr. Frank Gerratana, Chairperson. 5 Also present are Dr. Ralph Rosenberg and Dr. Sokpoleak Present from the Office of the State Comptroller Retirement б so. Services Division are staff members from the Retirement Services 7 8 Division, including Helena Bartolomeo, Alexandra Cipolla, Patrick Fairbanks and Robert Helfand. 9 10 The general counsel today for the Retirement 11 Commission and Medical Examining Board is Attorney Robin Kallor. I'll accept a motion to go into Executive Session for 12 13 the purposes of discussing individual member's disability health 14 issues, and I'll request that members of the Retirement Services Division and Counsel be allowed to remain. Is there a second? 15 16 DR. ROSENBERG: Rosenberg, I second. 17 CHAIRMAN GERRATANA: Any discussion? All those in favor? 18 Aye. 19 DR. ROSENBERG: Rosenberg, aye. 20 DR. SO: So, aye. 21 CHAIRMAN GERRATANA: The motion passes. 22 (Executive Session from 9:03 a.m. to 12:20 p.m.) This is Dr. Frank Gerratana. 23 CHAIRMAN GERRATANA: I'll make this statement. The Board will be making 24 25 determinations and voting on those determinations, but we'd like

1 to remind members that only the final vote will be given today and not the reasons for the vote. In some instances there may 2 3 not have been enough medical information to make a 4 determination, or perhaps a service connected disability is more 5 likely a non-service connected disability. You may seek reconsideration of an initial denial. б 7 You will receive the Board's written determination within 2 to 4 8 weeks, which will provide you with that additional information. 9 At this point we will vote on individual applicants. 10 Concerning Lisa Carter, I move that a request for continued 11 entitlement on reconsideration be denied. Is there a second? DR. ROSENBERG: Rosenberg, I second. 12 13 CHAIRMAN GERRATANA: Any discussion? All those in 14 favor? Gerratana, aye. 15 DR. ROSENBERG: Rosenberg, aye. 16 DR.
