3	CHAIRMAN GERRATANA: Good morning, everyone. I'm Dr.
4	Frank Gerratana, Chairperson of today's meeting of the Medical
5	Examining Board which is now in session. The date is May 21,
6	2025.
7	Also present are Board Members Dr. Nikolai Lieders and
8	Dr. Ralph Rosenberg. Present from the Office of the State
9	Comptroller, Retirement Services Division are staff members from
10	the Retirement Services Division Helena Bartolomeo, Alexandra
11	Cipolla, Patrick Fairbanks, Robert Helfand and Nabil Waheed.
12	The General Counsel for the Retirement Commission and Medical
13	Examining Board is Cindy Cieslak.
14	I make a motion that we go into Executive Session for
15	the purposes of discussing individual member's disability health
16	issues, and I request that the members of the Retirement
17	Services Division and Counsel be allowed to remain. Is there a
18	second?
19	DR. LIEDERS: Yes. Lieders, second.
20	CHAIRMAN GERRATANA: Any discussion? All those in
21	favor say, aye. Gerratana, aye.
22	DR. LIEDERS: Lieders, aye.
23	DR. ROSENBERG: Rosenberg, aye.
24	CHAIRMAN GERRATANA: The motion is approved.
25	ATTORNEY CIESLAK: All right, thank you, Dr.

Gerratana. This is Cindy Cieslak. What that means for everyone here is I'm going to place you in the waiting room. The doctors are going to go through the agenda one by one, because we discuss your confidential medical information it is a private Executive Session so that it's not open to the public.

If you're on reconsideration, you'll be invited in to make a statement. Once the doctors have discussed all of the members, we will enter public session and the doctors will announce their decisions in public session. So while you're in the waiting room, just hang tight and it, you know, sometimes these meetings do take a couple of hours. So if you're in the waiting room for a period of time, that is why. We didn't forget about you. We'll invite you in when public session enters again.

Gerratana. I have an informational announcement. The Board

will be making determinations and voting on those

determinations, but would like to remind members that only the

final vote will be given today and not the reasons for the vote.

2	medical information to make a determination, or perhaps a
3	service connected disability is more likely a non-service
4	connected disability. You may seek reconsideration of an
5	initial denial. You will receive the Board's written
6	determination within 2 to 4 weeks which will provide you with
7	that additional information.
8	The Board will be voting on the applicant's requests,
9	and we'll start with concerning Cynthia Cassada.
