## I. Call to Order

Commissioner Jackson called the meeting to order at 10:08 am.

## II. Adoption of Minutes from May 18 regular meeting and June 1 special meeting

Ms. Srivastava made a motion, seconded by Mr. Sayour, to approve the minutes of the May 18, 2018 regular meeting. There was no discussion and the minutes were approved on a unanimous vote with Thomas Sennett abstaining.

Ms. Srivastava made a motion, seconded by Mr. Sayour, to approve the minutes of the June 1, 2018 special meeting. There was discussion and the minutes were approved on a unanimous vote.

## III. Introduction and Swearing in of the new CRSA Board Members

Mr. Sennett stressed that Connecticut can learn lessons from other states who have already implemented a retirement security program in order to avoid unnecessary expenses. Commissioner Jackson agreed and said that the CRSA Board will continue to be in contact with other states.

Mr. Sennett stated that the work of this committee can be folded into the work of all the other subcommittees.
